Thank you for your trust in HSBC Bank (China) Company Limited ("we" or "HSBC China"). The time-limited monthly fee waiver period of Premier account service is from 11 June 2024 to 31 October 2024 (inclusive). We will look at your daily average Total Relationship Balance in October and adjust your account service type based on the qualification criteria and the requirement at that time.

- 1) If your Total Relationship Balance in October meets the Premier Minimum Total Relationship Balance requirement (CNY 500,000 or equivalent), we will maintain Premier account service for you since November 2024. If the Total Relationship Balance of all the accounts under the same customer number falls below CNY500,000 or equivalent, we will charge Premier monthly service fee of CNY 300 or equivalent unless it meets the criteria of exempting monthly service fee in <Tariff of Accounts and Services for Wealth and Personal Banking Business>.
- 2) If your Total Relationship Balance in October does not meet the criteria of exempting monthly service fee for Premier account service, we will adjust your account service type to Advance since November 2024. Advance account service will not be charged monthly service fee. From 15 October 2024, the Advance minimum Total Relationship Balance requirement and monthly service fee will be removed.

After the account service type adjustment, there will be changes of your account service type standard and service scope. The main service and fee comparisons are as following for your reference. Such criteria and fee standard might be changed by HSBC China from time to time. Please refer to our website for the most updated information.
